"Contract Rate Sheet" means the 'Tour Operator Contract Rates' sheet(s) attached to these Terms and Conditions.

"Hotel" means the Hotel listed on the Contract Rate Sheet.

"Privacy Laws" means the Privacy Act 1988 (CTH) and any other legislation, principles, industry codes and policies relating to the handling of personal information.

"Tour Operator or "You" means the operator or wholesaler named in these Terms and Conditions.

"Tour Operator Contract" means these Terms and Conditions together with the Contract Rate Sheet(s).

1. RATES & TAXES

- a. The statutory GST and any other taxes and levies added depend on the location of the Hotel and are subject to change.
- b. Should the applicable GST rate and any other taxes and levies as imposed by governmental and/or regulatory bodies increase or decrease after the conclusion of this agreement, rates granted by Nesuto Hotels & Apartment Hotels will be readjusted accordingly. For FIT & group contracts, the applicable GST rate will be the rate in effect at the date of payment.
- c. Contract Rates for Hotels are valid for International and Domestic Leisure Business only.
- d. Contract Rates and Specials including Bonus Offers are valid for leisure FIT and leisure groups up to the number of rooms detailed on the individual
- e. Contract Rate Sheet, subject to availability during the term of the Tour Operator Contract.
- f. Contract Rates for meetings, incentives, conventions or exhibitions may vary, and are subject to availability.

The Contract Rates are not to be offered by Tour Operator direct to the consumer, or, through owned, affiliated or subsidiary companies or knowingly or unknowingly to any party that distributes or retails via the Internet, or to any party that causes distribution or retailing via the Internet, without prior written approval from Nesuto Hotels & Apartment Hotels Sales Office, such approval to be in the absolute discretion of Nesuto Hotels & Apartment Hotels.

If the Tour Operator Contract fails to observe its obligations under this Agreement, then provided such failure continues for 7 days after Nesuto Hotels & Apartment Hotels calls by notice on the Tour Operator to remedy such failure, Nesuto Hotels & Apartment Hotels may by notice in writing to the Tour Operator terminate this Agreement.

Internet rates and tour operator contracts are available by contacting the Nesuto Hotels & Apartment Hotels Sales Office.

For the avoidance of doubt, the rates offered in this Agreement are NOT APPLICABLE for sale on hotel only (non-packaged) basis via online consumer channels including, but not limited to, the Tour Operator's own, affiliate, partner or onward distributor's websites. It is the Tour Operator's responsibility to enforce this clause.

4. HOTEL REFURBISHMENTS

The Tour Operator acknowledges that the Hotel may from time to time if necessary or reasonably required by Nesuto Hotels & Apartment Hotels, refit, renovate and/or redecorate the Hotel to a standard to Nesuto Hotels & Apartment Hotels or the Owner's satisfaction ("Refurbishment"). Except where the Hotel takes action as a reasonable response to an emergency situation or in compliance with any duty imposed by or under any law, the Hotel will use reasonable endeavors to inform the Tour Operator in writing of the nature and timing of the Refurbishment. 5. TOUR OPERATOR FOC Policy (Tour Leader/Escort)

For groups of 10 rooms or more, for every 10 fully paid room utilised per night, the 11th room will be complimentary (This is not applicable for Nesuto Geraldton Apartment Hotel), for the tour escort, up to a maximum of 2 complimentary rooms per group, per night, unless otherwise negotiated. Additional complimentary allocation for larger groups will be negotiated separately. The tour escort will receive pre-booked group meals complimentary (food only) for groups with pre-booked meal plans. Unless otherwise stated in individual contract rates.

For groups of less than 10 paid rooms, but more than 5 paid rooms the tour escort's room and pre-booked group meal is payable by You at 50% of the Contract Rate for that specific group.

6. ARRIVAL TIME

Check-in time cannot be guaranteed prior to 1400 on the date of stay. Immediate check-in prior to 1400 requires full pre-registration.

Check-out time 1000 unless prior arrangements are made. Unless otherwise stated in individual contract rates.

7. NESUTO HOTELS & APARTMENT HOTELS CREDIT POLICY

Hotel credit application should be made directly with the Hotel.

Please note that Hotel without credit accounts set up for the Tour Operator's company are not obliged to accept the Tour Operator's vouchers until the application has been submitted and credit has been approved in writing by Nesuto Hotels & Apartment Hotels.

8. PAYMENT

The Tour Operator's voucher is accepted, and full payment must be made by You within thirty (30) days of receipt of the Hotel's invoice.

Please note this is subject to credit application approval from the hotel prior to arrival of clients). Credit Accounts reaching 45 days outstanding, will automatically be suspended until outstanding monies are paid.

Full prepayment must be made by You to the Hotel 7 days prior to arrival of guest(s).

The Tour Operator is expected to follow the agreed payment procedure otherwise it will be deemed necessary to cancel the Tour Operator Contract.

Credit Card Charges - Fees are applicable when using a credit card to pay for accommodation and to settle any incidentals. A credit card fee of 1.5% applies to payments made by all credit card types (Please note: fee is subject to change).
Charges will be made and are payable by the Tour Operator as outlined in these terms and conditions.

9. DEPOSIT / CANCELLATIONS / NO-SHOW POLICY

FIT Reservations.

The following provisions apply except during special event periods.

- In the event of a cancellation within 6pm prior to arrival date or in the case of non-arrival, You must pay a fee of equal to the first night's accommodation.

Ad Hoc Groups for Non Credit Account.

Unless otherwise specified in the group contract, the following provisions apply except during special event periods.

A group is deemed to be for 10 rooms or more and for this Nesuto Hotels & Apartment Hotels will need the following:

- a. At 90 days prior to the arrival date a review of room requirements with a deposit equal to 10% of the total value of the reservation.
- b. Between 90 - 30 days prior to the arrival date, 50% of rooms booked maybe cancelled without penalty. Additional cancellations result in the forfeit of 10% deposit.
- c. At 30 days prior to the arrival date a full rooming list and payment of 50% of the total cost of accommodation for all rooms booked at the Hotel with release of all rooms for which a deposit has not been received, including unused reserved rooms.
- d. If groups are cancelled after the date which is 7 days prior to the arrival date, You must pay an amount equal to 100% of the total cost of accommodation for all rooms.
- e. Between 30 and 7 days prior to the arrival date, a further 2 rooms may be cancelled without penalty.
- f. You must provide a final rooming list with names and sharing requirement no later than 7 days prior to the arrival date.
- g. Full payment must be made on the date which is 7 days prior to the arrival date. This is applicable to all groups booked without credit facilities at the applicable Hotel.
- h. If rooms are cancelled within 72 hours You must pay the full accommodation charge for all nights for each room cancelled.

Ad Hoc Groups for Credit Account Clientele

Unless otherwise specified in the group contract, the following provisions apply except during special event periods.

- a. If rooms are cancelled between 14 and 30 days prior to the arrival date, you must pay a cancellation fee equal to 50% of the first nights accommodation.
- b. If rooms cancelled between 14 and 7 days prior to the arrival date, you must pay 75% charge of the total accommodation.
- c. You must prove an updated rooming list 30 days prior to the arrival date.
- d. You must provide a final rooming list with names and sharing requirements 7 days prior to the arrival date.
- e. If rooms are cancelled within 48 hours You must pay the full accommodation charge for all nights for each room cancelled.

Series Reservations

Unless otherwise specified in the group contract, the following provisions apply except during special event periods.

- a. You must provide a preliminary rooming requirement update at least 60 days prior to the arrival date.
- b. You must provide a final rooming requirement update at least 21 days prior to the arrival date.
- c. If rooms are cancelled between 21 to 14 days prior to the arrival date, you must pay 30% of all room charges, but where the same group in a series uses a hotel more than once for the same group, then the charge will only be with respect to that groups first stay at the hotel.
- d. If rooms are cancelled after 14 days prior to the arrival date, you must pay 100% charge of the first stay at the hotel.
- e. A final rooming list with names and sharing requirements is required 7 days prior to the arrival date.
- f. If rooms are cancelled after the date which is 7 days prior to the arrival date, you must pay 100% of room charges and pre booked meals for the first stay at the hotel.
- g. Please note that all cancellations must be in writing direct to the Hotel reservations department.

10. SPECIAL EVENTS POLICY

A Special Event Rate applies to all room types for any bookings, including bookings from any allotment.

Where dates have not been set or announced for a named event the following policy will apply:

13. RESERVATIONS

Reservations will not be considered as confirmed until the Tour Operator receives confirmation in writing from the relevant Hotel.

Telephone availability checks are not considered as a commitment for the reservation. Hotels are not required to provide verbal confirmation of availability.

A response (Hotel to Tour Operator direct) should be given within 4 hours from receipt of booking request, during business hours 8am-6pm local time to FIT bookings - allotment, free sale and request and Non-special event ad hoc groups.

A response (Hotel to Tour Operator direct) should be given within 24 hours from receipt of booking request to: all allotment requests (increases, new requests or amendments); bookings over and above allotment during special events; special event ad hoc group bookings.

A response (Hotel to Tour Operator direct) should be given within 2 days from receipt of booking request to a tour series with multiple departures.

14. ALLOTMENTS

Allotments negotiated for Hotel must materialize at a rate higher than 80%. If not achieving this level, then Nesuto Hotels & Apartment Hotels has the right to reduce allotment size to match allotment materialization criteria. An evaluation will take place each (3) months.

Hotel automatically release negotiated room allotment space at agreed release dates. Reservations after release date are on request only basis, via the Hotel reservations department only.

15. AMENDMENTS

Amendments to a Tour Operator Contracts shall only be valid if made in writing and signed by the Hotel (and then only in relation to the Contract Rate Sheet for that Hotel) and/or Nesuto Hotels & Apartment Hotels by notification from its Sales Office. Telephone changes are not accepted.

16. BONUS/SPECIAL OFFERS

Bonus/Special Offers are not valid in conjunction with any other offer, except for the Honeymoon offer (if applicable to the specific hotel)

Bonus/Special Offers are not available during special event periods unless otherwise stated on the hotel contract page.

17. CONFIDENTIALITY AND PRIVACY

The Tour Operator confirms and agrees that the Tour Operator Contract is confidential between the Tour Operator, Nesuto Hotels & Apartment Hotels and the Hotel.

The Tour Operator shall not in any circumstance divulge or permit to be divulged the contents of the Tour Operator Contract.

The Tour Operator warrants that it has complied with its obligations under all Privacy Laws and that Nesuto Hotels & Apartment Hotels and the Hotel are authorized to use information which comes into their possession under the Tour Operator Contract.

Tour Operator Contracts may not be assigned or transferred from one Tour Operator to another without specific authorization of Nesuto Hotels & Apartment Hotels

18. RIGHT TO TERMINATE

If either the Tour Operator or Nesuto Hotels & Apartment Hotels fails or neglects to perform or observe the covenants it is required to perform or observe under the Tour Operator Contract ("the defaulting party") and such failure continues for a period of 7 days after service of a notice from the other of them ("the non-defaulting party") calling upon the defaulting party to remedy the failure, then the non-defaulting party can terminate the Tour Operator Contract without prejudice to any rights of the parties arising prior to such termination and any rights of action or remedies of the non-defaulting party in respect of the breach, non-performance or non-observance of a covenant or term of the Tour Operator Contract.

19. NESUTO HOTELS & APARTMENT HOTELS AS AGENT

The Tour Operator acknowledges that Nesuto Hotels & Apartment Hotels has entered into this Tour Operator Contract in its own right in respect of the hotel business being carried on and agrees that to the extent that the obligations described in this Tour Operator Contract on the part of Nesuto Hotels & Apartment Hotels are required to be performed by Agent Hotels, Nesuto Hotels & Apartment Hotels has no personal liability for such obligations.

Where the hotel is removed from the ambit of this Tour Operator Contract, Nesuto Hotels & Apartment Hotels will have no further liability to the Tour Operator under this Agreement in respect of that Hotel. Nothing in this paragraph should be construed as implying that Nesuto Hotels & Apartment Hotels has any obligations to the Tour Operator with respect to Agent Hotel.

All obligations on the part of Nesuto Hotels & Apartment Hotels contained in this Tour Operator Contract which have to be performed by more than one party are several obligations and not joint and several.

The Supplier must:

- (i) provide to the Recipient a tax invoice in respect of the payment complying with any legislation under which GST is imposed; or
- (ii) have provided, prior to the time of payment, an authority authorizing the Recipient to issue, on behalf of the Supplier, a Recipient-created tax invoice ("RCTI") in respect of the payment and which authority is, at the time of payment, valid and satisfying the requirements of any relevant authority (it being understood by the parties that such RCTI will, under the GST legislation, have effect as if the tax invoice had been issued by the Supplier in compliance with any legislation under which GST is imposed) and the Recipient's obligation to pay a GST Amount will be conditional on compliance by the Supplier with this clause.

20. GST

Each party ("Recipient") must pay to the other party ("Supplier") any amount which is payable by the Supplier on account of good and services tax, value added tax or any other like tax ("GST") as a consequence of any supply made or deemed to be made to the Recipient ("GST Amount"). Nothing in this clause requires the Recipient to pay any amount on account of a fine, penalty, interest or other amount for which the Supplier is liable as a consequence of a default of the Supplier, its employees, agents or any other persons acting for the Supplier, except if the fine, penalty, interest or amount arises a result of the Recipient not obligations hereunder.
