BOOKING TERMS AND CONDITIONS

These terms and conditions form part of an agreement between the Tasmanian Walking Company Pty Ltd (company) and the guest(s) referred to in the booking form.

1. How to book

Either phone or email our reservations team to confirm availability. Once a tentative booking has been made, we will forward a confirmation and deposit request of \$500, along with a guest information form which the guest must complete within 5 working days of the booking being made otherwise the tentative booking will be cancelled. The form can be returned to us online or a scanned copy. Bookings are not confirmed until a deposit has been received (see below) and availability on the walk requested has been confirmed.

2. Pricing

Prices are quoted on a seasonal basis. Please refer to your rates to determine season of experience booked. Please note prices may change within the contracting period and we will notify you of any changes. Tasmanian Walking Company will provide a 30-day grace period before price changes take effect. For this reason, should you be using rates in any brochures please note prices start from *

Pricing includes: Pick up and drop off from collection and return point designated by the Company, transport to the start of the relevant walk experience, including, where applicable, any ferry transfers, twin share accommodation during the walk, food, limited non-alcoholic beverages and wine, all National Park entry fees qualified staff for the duration of the walk; and use of backpack and weatherproof jacket (if required) for duration of walk. Any other cost is borne by the guest.

No price reduction is available for guests who either elect to bring their own alcohol or choose not to avail themselves of the food or drink provided. The Company abides by responsible service of alcohol principles as it promotes a safe and enjoyable environment for all guests and staff, and reduces the risk of alcohol-related injury. The Companies guides have absolute discretion around the provision of alcohol (including BYO alcohol) and will stop serving and/or prohibit continued consumption of alcohol if guest(s) appear (in the opinion of the guides) drunk or become violent, quarrelsome, disorderly or behave indecently.

Without limitation, the following items are excluded from the pricing: Spa and relaxation pavilion treatments, travel insurance, pre and post walk departure arrangements, including accommodation and transport to the collection point and from the return point designated by the Company, any expenses not defined as an inclusion in the pricing including tips, personal clothing, medical expenses, items of a personal nature and emergency evacuations.

3. Single Supplement

Most of our accommodation is twin share and our walk prices are based on twin share (two people sharing one room). Solo travellers are always welcome and if a single room is requested, a supplementary price will apply, please refer to rates in appendix A. Solo travellers can also choose to be matched with another solo traveller and only pay the twin share price. Requests for single supplement must be stipulated at the time of booking.

4. Public Holiday Surcharge

If a departure falls on a public holiday an additional \$200 surcharge is applied to the departure to cover the increased cost of operation. To see a full list of applicable public holidays, click [here](#).

5. Payment

All pricing is in Australian dollars and are quoted on a per person twin share basis. A single supplementary price for singles is available (as above).

DEPOSIT: Bookings are not confirmed until a deposit of \$500 per person has been received (within 5 working days of bookings being made), if the booking is made more than 90 days prior to departure (180 days for Uluru-Kata Tjuta Walks). For Reservations made 90 days or less from departure date (180 days for Uluru-Kata Tjuta Walks), full payment is due at the time of booking.

FINAL PAYMENT: The balance of the booking price is payable to the Company at least 90 days prior to departure (180 days for Uluru-Kata Tjuta Walks). For reservations made 60 days or less from the departure date (180 days for Uluru-Kata Tjuta Walks), full payment is due at the time of booking.

Once the required deposit has been paid, any subsequent discounts or price reductions that are advertised by the Company or any third party will not be applied retrospectively.

Payment may be made by direct deposit, or company credit card (credit card surcharge applies). We do not accept payment by any other method, including cheque or foreign debit cards

We do not charge a fee for payments made via

- direct deposit, or Australian Visa or MasterCard "debit" card.

However, we do charge the following payment fees for the following transactions:

- 1% fee for Australian Visa and MasterCard "credit" cards;

- 2% fee for all foreign Visa and MasterCard "credit" cards; and
- 3% fee for all American Express cards.

All payment fees are subject to change. The payment fees specified on our website are the most current.

6. Cancellation by Guest

The date of cancellation is the date that the Company receives written notice of the cancellation.

- if the cancellation is made more than 90 days from departure (180 days for Uluru-Kata Tjuta Walks), a fee of \$350 per person will be charged.
- for cancellations made between 90 and 60 days prior to departure (180 and 150 days prior for Uluru-Kata Tjuta Walks), a fee of 50% of full price will be charged.
- For cancellations within and including 60 days of departure (150 days for Uluru-Kata Tjuta Walks), no refund is available.

Cancellation by the guest will also take effect if:

- the guest fails to arrive at the pre-arranged meeting place at the time stipulated by the Company; or
- payment of the balance of the booking is not received by the Company by the required time as stipulated in condition 5.

No refund will be paid if the guest:

- voluntarily leaves the walk after it has commenced. No refund will be paid if the guest needs to leave the walk for reasons of bereavement, injury or illness; or
- are directed by the Company to leave or not commence your walk in accordance with these terms and conditions.

We strongly recommend that all guests obtain suitable travel insurance.

The Company reserves the right to not provide a refund if the guest arrives on the day of departure for any walk with inappropriate footwear and are unable to join the walk (please refer to condition 12)

7. Booking Amendment by Guest

If the guest wishes to change the booking, you must notify the Tasmanian Walking Company in writing as soon as possible. Once notice has been received and confirmed by Tasmanian Walking Company, the change will take effect subject to the following:

- one amendment can be made to the original booking outside of 90 days from departure (180 days for Uluru-Kata Tjuta Walks), at no cost.
- a \$200 per person fee will be charged for any further amendments made by a guest 90 days prior to the departure date (180 days for Uluru-Kata Tjuta Walks).
- for booking changes made between 60-90 days from departure (150 and 180 days prior for Uluru-Kata Tjuta Walks), there is a \$350 fee to change the departure date;
- we do not accept changes to bookings within 60 days of departure (150 days for Uluru-Kata Tjuta Walks).

Changes to the guests walk departure date, or transfer of booking to a different walk may incur additional costs payable by the guest for any difference in pricing. We will do our best to change the guests booking to their preferred date, but it may not be possible.

8. Cancellation by the Tasmanian Walking Company

All walks take place in very special wilderness settings. We are at the mercy of nature in all her beauty and all her fury. We will under no circumstance knowingly place at risk the health and well-being of our guests and guides. In the case of a Force Majeure Event (as defined below) we may need to cancel a walk with very little notice. In some cases, this can occur after the walk has commenced.

If a walk does not meet minimum numbers, Tasmanian Walking Company reserves the right to cancel the departure; however, every effort will be made to consolidate numbers so that the booked walk will successfully depart.

If we cancel a walk departure for any reason, we will provide the following options:

- hold a credit toward an alternative booking departure date to be used within 24 months, including a guarantee there will be no additional charges for the future walk;
- provide a replacement walk that complements your existing travel arrangements (subject to availability);
- provide a replacement walk at a later date that is convenient to both parties; or
- with the exception of cancellations associated with a Force Majeure Event, we will refund the full amount paid for the cancelled walk.

Where a walk is cancelled by Tasmanian Walking Company, we will not be liable for any costs associated with travel to and from the designated walk departure pick up point. We therefore strongly recommend travel insurance to be taken out at time of booking.

9. Evacuations

In rare circumstances, due to injury or unforeseen illness, we may need to evacuate the guest from a remote part of the walk. Where an evacuation is deemed necessary by the Company, the full cost of evacuation will be borne by the guest, including but not limited to helicopter costs, any associated staff wages and ground transportation costs.

For Australian residents, under the Australian Government Medicare Act, it is prohibited for any domestic travel insurance product to provide any financial reimbursement with regard to ambulance or air ambulance services.

We therefore strongly recommend guests:

- take out specific ambulance cover through their health insurance provider; and
- take out travel insurance to cover (amongst other things) the costs associated with evacuation.

10. Travel Insurance

When selecting a travel insurance product, please ensure that it provides cover against, at a minimum, personal accidents or injury, medical expenses, Force Majeure Events, emergency repatriation and personal liability, cancellation for any reason including bereavement, delayed flights, lost luggage and personal effects.

We strongly recommend that all guests obtain suitable travel insurance once your deposit payment is made.

11. Indemnity

You hereby agree to indemnify and at all times hereafter keep indemnified and hold harmless the Company, its related entities and its and their officers, employees, guides, servants and agents or any of them (Indemnified Persons) from and against all costs, claims, actions, demands and liability whatsoever and howsoever arising from or in any way connected with the walk and your participation in the walk (including any transportation to or from the area in which the walk is to take place) including such costs, claims, actions, demands or statutory duty or otherwise on the part of the Indemnified Persons, and including any liability in respect of or related to my/our death, personal injury, or loss of or damage to any property owned or possessed by me/us, but excluding any liability which cannot be excluded by applicable laws. The Company holds the benefit of any rights accruing to the Indemnified Persons under this paragraph on trust for the Indemnified Persons, and you acknowledge and agree that the Company can enforce such rights in its own name or in the name of the Indemnified Persons as their trustee.

12. Footwear

On the Cradle Mountain Huts Walk guests are required to wear lace-up walking boots which have ankle support and firm treaded soles. Walking shoes are not acceptable on the Cradle Mountain Huts Walk and sandals and similar footwear are not acceptable on any of our walks.

On all other walks, guests are required to wear supportive walking shoes or hiking boots with firm treaded soles. New boots should be worn in prior to the commencement of the walk. Waterproof or water-resistant boots are recommended.

These recommendations are made in the interests of your safety and giving you the best chance to have the most enjoyable experience possible. Arriving on the day of departure for any walk with inappropriate footwear may result in forfeiting your walk without refund. If you are unsure whether your footwear is suitable for your intended walk, please contact our reservations team for further advice.

13. Health and Fitness Requirements

All guests must complete a fitness for walk questionnaire as part of the booking process.

It is the responsibility of the guest to read through the itinerary carefully and ensure they have adequate fitness for the proposed trip.

Guests must be in good health and have the appropriate physical and mental fitness to maintain a good walking pace for the duration of their walk. Some training and preparation work is required prior to departure. The more physically and mentally prepared you the guest is, the more enjoyable the walk will be. Speak with our reservations staff for more information about health and fitness requirements and walk preparation. As a general indication, prior to the trip all guests should be able to safely complete a 15-20km day walk on varied terrain including bush trails and inclines, whilst carrying a 7-10kg backpack. Specific trail distances and features can be found in guest trip notes.

No guest should present for the start of trip if they are unwell and symptoms would impact their ability to complete the walk safely. Guides or other trip leaders may choose to evacuate a guest off trip if they have concerns about the ability of guests to complete the walk safely due to illness.

The Company reserves the right in its absolute discretion to refuse a guest the right to participate in a trip on medical or fitness grounds.

14. Medical Forms and Doctors Certificates

Guests with a pre-existing medical condition, including allergies, are required to disclose it in the booking portal and may be required to supply a doctor's certificate where risk is elevated due to our walks operating in remote locations.

Guests who are 70 years of age or older, at the time of departure, must supply a doctor's certificate, no later than 90 days prior to departure, stating that they are in good physical condition and that there are no known ailments or pre-existing medical conditions likely to prevent them from completing the walk. This step assists us to ensure an enjoyable and trouble-free walk for all involved, as risk is elevated due to our walks operating in remote locations.

15. Dietary Requirements

Dietary requirements stating whether it is a lifestyle choice or allergy must be noted on the booking form. We will endeavour to cater to your needs, but we operate in remote locations which in some cases are only provisioned twice per year.

If dietary requirements are not disclosed at least 90 days prior to your departure date we may not be able to cater to your needs. Should you need to cancel your trip because you have not disclosed dietary requirements in a timely manner, standard cancellation fees will apply (refer to condition 6).

16. Guide and Guest Responsibilities

All our walks are group trips and guests need to be conscious of how their actions may impact others. All guests and staff must be respectful and mindful of people's differences, including protected attributes such as race, gender identity and religion. Guests must be able to understand and follow safety instructions given in English or be travelling with a guest who is able to.

The Company's guides and support staff take their roles and responsibilities seriously and if for any reason the trip leader believes, in their absolute discretion, that you should not participate in the trip, they may exclude you from the trip. In this event, without prejudice to any other condition in these terms and conditions, you may be offered the option of taking another walk considered suitable for you or a partial refund. The trip leader includes both the nominated lead guide and any other person nominated by or on behalf of the Company to lead or supervise any aspect of the trip.

The trip leader is in charge to ensure not only your safety, but the comfort, safety and enjoyment of the entire group. If for any reason during a trip the nominated trip leader considers you should not participate further due to you committing an illegal act, or in the opinion of the nominated tour leader, your behaviour is causing or may cause danger, distress or annoyance to others, the nominated leader may direct you not to continue on the trip and you must follow their instructions. In this case you will not be entitled to any refund. Travel insurance may compensate you depending on the circumstances (and the terms and conditions of the relevant policy). The trip leader includes both the nominated lead guide and any other person nominated by or on behalf of the Company to lead or supervise any aspect of the trip.

17. Environmental Responsibilities

The Company operates within the Wilderness World Heritage Area and National Parks. Therefore, our environmental responsibilities are taken very seriously. Prior to departure, guests will be briefed about such responsibilities, however prior knowledge and awareness is extremely helpful.

18. Exclusion of Liability

Guests acknowledge that walking in a wilderness area of a National Park is potentially a dangerous activity and guests are undertaking such an activity at their own risk. Guests acknowledge and agree that they will undertake the walk freely, voluntarily and absolutely at their own risk and with a full appreciation of the nature and extent of all risks involved in the walk. Guests acknowledge that the Company is supplying them with Recreational Services (as defined below) for the purposes of applicable laws.

Guests agree to the fullest extent permitted by law waive all of their legal rights of action against and fully release the Company and its officers, directors, employees, servants, agents or consultants from all liability arising from or connected with their death or personal injury howsoever arising out of or in relation to the participation by them in a walk including without limitation, liability for a negligent or tortious act or omission, breach of duty, breach of contract or breach of statutory duty on the part of the Company, its officers, directors, employees, servants, agents or consultants. This waiver shall bind all guests and their legal personal representatives.

19. Limitation of Liability

The Company does not exclude or limit the application of any provision of any statute (including the Competition and Consumer Act 2010 (Cth)) where to do so would:

- contravene that statute; or
- cause any part of these terms and conditions to be void.
- Except to the extent condition 18(a) applies, and to the extent permitted by law, the Company excludes all:
 - statutory liability;
 - tortious liability (including negligence);
 - conditions and warranties implied by custom, the general law or statute; and
 - liability for all special, indirect, incidental, consequential or punitive damage and economic loss, loss of profits, loss of revenue, loss of bargain, loss of goodwill, loss of anticipated savings, or loss of use of products or equipment, arising out of or relating to these terms and conditions, the walk, or any failure to supply or delay in supplying the walk, whether or not the Company was aware or should have been aware of the possibility of such loss or damage.

The Company's liability to guests for any breach of any express or implied provision of these terms and conditions is limited, at the Company's option, to:

- refunding the price of the goods or services in respect of which the breach occurred; or
- providing, replacing or repairing those goods or providing those services again.

Guests agree to indemnify and hold harmless the Company and each of its officers, directors, employees, servants, agents or consultants against any losses, costs, claims, damages, expenses, liabilities, proceedings or demands which any of them may directly or indirectly incur or suffer as a consequence of any breach by them of their obligations under these terms and conditions.

20. Jurisdiction

The law of state the walk is taking place in shall apply to these terms and conditions.

21. Acknowledgement

By placing a booking with the Company, guests acknowledge and agree that the Company has relied on the representations made by you, including in respect of your circumstances, travel insurance availability, age and medical condition which representations you hereby confirm and warrant are true, correct and complete in every respect.

22. Definition

"Force Majeure Event" refers to an event(s) or circumstance(s) which includes, but is not limited to, acts of God, natural threats (such as bush fires, impassable snow and unsafe sea conditions), fire, earthquake, flood, windstorm or other extreme weather events civil commotion, riot, blockade or embargo, breakdown, union dispute, epidemic, pandemic, lack or failure of courses of supply, passage of any law, order, regulation, ordinance, proclamation, demand, requisition or requirement or any other act of any government authority, outside of the

reasonable control of either parties whether or not foreseeable, which renders performance impossible; and

"Recreational Services" means services that consist of participation in a sporting activity or a similar leisure-time pursuit; or any other activity that:

involves a significant degree of physical exertion or physical risk; and

is undertaken for the purposes of recreation, enjoyment or leisure.

23. Trade Agreement

Payment Details

Bookings are not confirmed until a deposit of \$500 per person has been received (within 5 working days of bookings being made), if the booking is made more than 180 days prior to departure. For Reservations made 180 days or less from departure date, full payment is due at the time of booking.

Cancellation by Guest

If the cancellation is made more than 180 days from departure, a fee of \$350 per person will be charged. For cancellations made between 180 and 150 days prior to departure, a fee of 50% of full price will be charged. For cancellations within and including 150 days of departure, no refund is available. The date of cancellation is the date that the Company receives written notice of the cancellation.

Booking Amendment by Guest

If the guest wishes to change the booking, you must notify the Tasmanian Walking Company in writing as soon as possible. Changes to the guests walk departure date, or transfer of booking to a different walk may incur additional costs payable by the guest for any difference in pricing. We will do our best to change the guests booking to their preferred date, but it may not be possible. Once notice has been received and confirmed by Tasmanian Walking Company, the change will take effect subject to the following:

One amendment can be made to the original booking outside of 180 days from departure, at no cost. Any subsequent change will incur a non-refundable fee of \$200 per person. For booking changes made between 150-180 days from departure, there is a \$350 fee to change the departure date. Tasmanian Walking Company does not accept changes within 150 days of departure.
